To the Members of

Report on the Financial Statements

We have audited the accompanying financial statements of **Butala Farm Land Private Limited** ("the Company"), which comprise the Balance Sheet as at March 31, 2016, the Statement of Profit and Loss and Cash Flow Statement for the year then ended, and a summary of significant accounting policies and other explanatory information.



Note "H"

NOTES TO ACCOUNTS

A. SIGNIFICANT ACCOUNTING POLICIES:

a) System Of Accounting

The company follows the mercantile system of accounting and recognizes income and expenditure on accrual basis.

b) Basis of Preparation of Financial Statements

The Financial statements have been prepared under the historical cost convention in accordance with the generally accepted accounting principles in India mandatory Accounting Standards issued by ICAI and the relevant provisions of the Companies Act, 2013.

c) Inflation

The financial statements are based on historical costs. These costs are not adjusted to reflect the impact of the changing value of the purchasing power of money.

d) Use of Estimates

The preparation of Financial Statements requires estimates and assumptions to be made that affect the reported amount of assets & liabilities on the date of financial statements. Difference between the actual results and estimates are recognized in the period in which the results are known/ materialized.

e) Revenue Recognition

1. Revenue is recognized when it is earned and no significant uncertainty exists on its realization.
2. Interest is recognized on time proportion basis.
3. Dividend income is recognized when the right to receive the same is established.

f) Investments

Investments are valued at cost of acquisition less diminution if any, of a permanent nature.

g) Provisions, Contingent Liabilities and Contingent Assets

Provisions involving substantial degree of estimation in measurement are recognized when there is a present obligation as a result of past events and it is probable that there will be an outflow of resources. Contingent Liabilities are not recognized but are disclosed in the notes. Contingent Assets are neither recognized nor disclosed in the financial statements.

h) Taxes on Income

Provision for current tax, if any, is made after taking into consideration benefits admissible under the provisions of the Income Tax Act, 1961.

Deferred tax, if any, resulting from "timing difference" between book and taxable profit is accounted for using the tax rates and laws that are enacted or substantively enacted as on the balance sheet date. The deferred tax asset, if any, is recognized and carried



forward only to the extent that there is a reasonable certainty that the asset will be realized in future.

B. Other Notes:

1. There are no Micro and Small Enterprises, to whom the Company owes dues, which are outstanding for more than 45 days as at March 31, 2016. The above information, regarding Micro and Small Enterprises has been determined to the extent such parties have been identified on the basis of information available with the Company. This has been relied upon by the Auditors.
2. In the opinion of the management, the Current Assets, Loans and advances are approximately of the value stated in the balance sheet if realized in the ordinary course of the business and provision for all known liabilities is adequate and not in excess of amount considered reasonably necessary.
