Sub: Scrutinizer's Report on Postal Ballot conducted as per Section 110 of the Companies Act, 2013 read with the Companies (Management and Administration) Rules, 2014

The Phoenix Mills Limited ('the Company') vide resolution passed by its Board of Directors at their meeting held on November 8, 2023, appointed the undersigned as the Scrutinizer to ensure that the process of voting by Postal Ballot vide Notice of Postal Ballot dated November 8, 2023 is conducted in the manner prescribed under Section 108 and Section 110 of the Companies Act, 2013 ('the Act') read with the Companies (Management and Administration) Rules, 2014 ("the Rules of Chapter VII") and other applicable provisions of the Act and the Rules made thereunder including various circulars issued by the Ministry of Corporate Affairs, Government of India ("the MCA Circulars"), Secretarial Standards on General Meetings issued by the Institute of Company Secretaries of India ("SS-2") and other applicable laws, rules and regulations (including statutory modification(s) or reenactment(s) thereof, for the time being in force).

As required under Section 110 read with Rule 20 and Rule 22 of the Rules of Chapter VII of the Act, a Notice of Postal Ballot dated November 8, 2023 along with the Explanatory Statement under Section 102 of the Act was sent to the shareholders through electronic means to vote through the mechanism of remote e-voting in accordance with the provisions of the Act and the Rules made thereunder and in compliance with requirements of the MCA Circulars on the resolution proposed as per the Postal Ballot Notice:

Marg, Vikhroli (West), Mumbai – 400083.

The Shareholders were required to vote electronically during the voting period commencing from 09:00 a.m. (IST) on Friday, December 01, 2023 upto 5.00 P.M. (IST) on Saturday, December 30, 2023. Accordingly, the members who casted their votes upto 5.00 P.M. (IST) on Saturday, December 30, 2023, have been considered for my scrutiny.

A summary of voting through remote e-voting with their pattern of voting is as per Annexure annexed to this Report.

The results of the voting by shareholders through remote e-voting in respect of the above mentioned resolution may accordingly be declared by the Chairman or the Company Secretary who has been so authorized by the Chairman in writing and who has also countersigned this Report.
